ORCHESTRA AUDITIONS

Positions in the Orchestra of the Maggio Musicale Fiorentino, for contracts based on production needs, as follows:

SECOND CLARINET,

with obligation to play the following positions. retribution: level 4 + 2.78%, artistic area)
and

E-FLAT CLARINET,

with obligation to play the following positions. retribution: level 3, artistic area)

The auditions are open to European Union citizens of either sex (D.Lgs. 196/2000), eighteen or older on the deadline date for application submission, and who possess a diploma in the required instrument, issued by a Music Conservatory or equivalent Music Institute in Italy or abroad.

Non-European Union citizens will also be admitted to the auditions, provided they already possess a valid residence permit allowing immediate employment with the Theater.

Participants must not have any criminal convictions, except for negligent offenses, and must have an adequate knowledge of the Italian language.

The auditions will take place at:

Teatro del Maggio Musicale Fiorentino, Piazza Vittorio Gui, 1 – Florence

Tuesday 8th, Wednesday 9th, Thursday 10th April, 2025,

with all candidates summoned at **9:00 AM**.

No notice of summons will be sent: each candidate must therefore show up at the Theater on the specified day and time and present a valid identity document, under penalty of exclusion.

The EXAMINING COMMISSION, composed of experts, will be appointed by the General Manager of the Theater and may require candidates, at its sole discretion, to perform the entire examination program (see below), or only part of it.

The RESULTS of the exams (preliminary rounds/ final round - numerical score) will be posted in the Theater's notice board; MINIMUM PASSING SCORE is **8.00 out of 10.00**.

PLEASE NOTE: two separate rankings will be drawn up, one for Second Clarinet, one for E-flat Clarinet

3. The **examination program** is as follows (for both Second Clarinet and E-flat Clarinet):

- W. A. Mozart Clarinet Concert in A major K622, I movement (exposition up to bar n. 154)
- C. Debussy Première Rhapsodie (up to bar n. 90)

ALL APPLICATIONS WILL RECEIVE A RESPONSE confirming the reception of the application. The Theater is not responsible for any transmission issues.

In the application (see sample form), the candidate must indicate: name and surname, place and date of birth, citizenship, and address of residence (including phone numbers, mobile, fax, and email), possession of the required educational qualifications; the application must be signed and the following attached: permit/residence card, for non EU Citizens, and a Curriculum Vitae.

Submitting the application implies unconditional acceptance of the final, non-negotiable judgment of the Examining Commission. Incomplete applications (including missing required attachments) or not using the forms provided by the Theater will not be accepted.

By participating in the selection process, the candidate acknowledges that passing it does not guarantee the right to permanent employment, but only the possibility of being included in a ranking through which the Theater may offer fixed-term employment contracts.

The final ranking resulting from this procedure will be valid and effective from April 11, 2025, until April 10, 2026.

The candidate also acknowledges that participation in this selection process fully exhausts any previous rankings and acquired rights from previous selection procedures, while the service rendered, for the sole purpose of maturing the right of precedence as regulated by the relevant laws, will still be considered.

Personal Data collected by the Theater during the selection procedure will be processed in accordance to the Legislative Decree 196/2003 and GDPR 2016/679. The information on personal data processing Article 13 of GDPR 2016/679 and Legislative Decree 196/2003 are available on the Theater's website, together with this selection notice.

The provision of data is mandatory for participating in the selection.
