Since 1893, Bournemouth Symphony Orchestra has represented artistic excellence. Throughout its illustrious history, BSO has worked with the finest composers, conductors and musicians in the world.

As an Orchestra, BSO's reach is exceptional: performing over 90 symphonic performances a year and 30 On Your Doorstep ensemble concerts in over 40 venues across the south and south west. BSO performs to 5,000 audience members a week through its main venue concerts. #### Main Purpose of the Job:

Working closely with the Orchestra Manager, the Assistant Orchestra Manager will assist in the management of the Bournemouth Symphony Orchestra's contracted and freelance musicians. This is a great opportunity to work with eminent international musicians and artists, and to be part of this exciting award-winning organisation.

The two orchestra managers will work closely together to ensure the best service for musicians and ensuring continuous orchestra management cover as necessary.

The Assistant Orchestra Manager will regularly attend rehearsals and concerts, ensuring the smooth running of all orchestra calls.

The Assistant Orchestra Manager will be a member of the Concerts Department team, reporting to the Orchestra Manager and working closely with other members of the department.

#### Main Responsibilities:

Engage freelance musicians, in consultation with Orchestra Manager and orchestra principals.

Be first point of contact for these musicians, with out of hours availability via the Assistant Orchestra Manager's mobile phone and email.

Calculate payment for freelance players on a weekly basis, providing payment information to the Finance Department.

Work with Orchestra Manager and section principals in devising and maintaining fixing lists.

Particular responsibility for fixing and concert duty for smaller ensemble concerts, working closely with the BSO's Participation Department.

### Assistant Orchestra Manager

Assist Orchestra Manager with short notice fixing of orchestra positions as the need arises.

Assist with freelance personnel administration such as sending schedules, gathering data.

Assist the Orchestra Manager with annual budgeting of freelance costs.

Work with the company's computer systems to monitor orchestral attendance.

Ensure timely and accurate personnel information is available to the Concerts Department.

Carry out venue risk assessments at rehearsal and concert venues as required.

Be on duty, shared with the Orchestra Manager, to ensure the smooth running of orchestra calls. This includes managing the start and running of concerts, working with front of house staff at concert venues, the BSO's digital team and broadcasters.

Assist Orchestra Manager with administration of contract players.

Orchestra Manager and Assistant Orchestra Manager provide cover to enable each other to have quality time off from the fixing mobile phones.

To operate with full regard for BSO company policy and BSO/MU agreements.

Work with the Head of Human Resources who offers both orchestra managers support on personnel matters and health and safety.

### **Person Specification**

Essential Knowledge, Skills and Experience

- Previous experience of working with professional musicians and a good knowledge of orchestral repertoire are essential.
- Consistent accuracy and attention to detail are essential in all aspects of the job.
- A willingness to work irregular hours, evenings and weekends is essential.
- Excellent communication skills, patience and empathy are required, as is a sense of humour.
- The post requires the ability to be calm under pressure and manage conflicting priorities.
- A current driving licence valid for the UK is essential.

- Experience of engaging professional musicians.
- Experience of using OPAS.
- A working knowledge of MU agreements.
