Information Auditions:

The auditions will be held in the building of Nederlandse Reisopera in Enschede. Please keep in mind that before the auditions, you will prepare each excerpt in its entirety, but you may only be asked to play part of it. Warming-up time of 30 minutes per candidate.

The first audition round will be held on Thursday 17 April 2025. Maximum duration per candidate: 45 minutes. Beforehand, the candidate gets 30 minutes of warm-up time in a practice room.

Part 1: Piano solo (free choice)

Play an extract of a piano solo work of your own choice, maximum duration 5 minutes. Judging criteria: *Technique, interpretation, and sound*.

Part 2: Mozart or Strauss opera repertoire

Play the overture to *Mozart's Le Nozze di Figaro* or Strauss'*Salomes Tanz* on piano. Judging criteria: *Technical mastery, dynamics, and musical expression*.

Part 3: Playing, singing and conducting from the piano

Perform the following works on the piano, (maximum duration 20 minutes):
a. *Carmen*, Quintet (French)
b. *Don Giovanni*, Final Act 1 with preceding recitative (Italian)
c. *Waiting for the Barbarians, Phillip Glass* (Engels), will be provided by email to the shortlisted candidates
d. An act from an opera chosen by the candidate himself.
Assessment criteria: *Flexibility, interpretation, timing and coordination*.

Part 4: Text recitation

Recite 4 spoken text extracts from a French, German, Italian and English opera libretto, the text will be supplied in the practice room during your 30 minutes warming-up time. Maximum duration total: 5 minutes. Assessment criteria: *Pronunciation, text comprehension, and presentation*.

Part 5: Sight-reading with minimal preparation

Play an unknown opera fragment which is provided in the practice room 30 minutes before. Maximum duration total: 5 minutes. Judging criteria: *Speed of understanding, technical accuracy, and musical interpretation.*

Part 6: Sight-reading (unseen)

Play a standard opera extract which is given on the spot without preparation (sight reading), maximum duration 5 minutes. Judging Criteria: *Ability to play music accurately and rhythmically without preparation, error correction.*
