

Stichting Omroep Muziek (SOM) is a production house for music within the Dutch public broadcasting system (NPO), employing approximately 240 staff members. The organization includes the Radio Philharmonic Orchestra and the Netherlands Radio Choir (Groot Omroepkoor). These ensembles are renowned for championing new and lesser-known music, both in the Netherlands and beyond. Every week, they bring audiences in major Dutch concert halls, as well as countless listeners at home via radio and online, the finest masterpieces of classical music. Their performances take place during the NTR ZaterdagMatinee, the AVROTROS Vrijdagconcert, and the Zondagochtend Concert, all broadcast live on NPO Klassiek. Additionally, SOM operates from its own building on Heuvellaan in Hilversum, which houses numerous recording studios, rehearsal spaces, and an in-house concert series.

About the Netherlands Radio Choir

For 80 years, the Netherlands Radio Choir has been a leading professional choir with a unique identity. Its repertoire spans from baroque to contemporary works, performed in small ensembles, a cappella, and primarily in large-scale choral symphonic compositions. The choir's strength lies in its flexibility—one week performing a Bach cantata, the next premiering works by Sir James MacMillan or Jörg Widmann.

As part of Stichting Omroep Muziek, the choir is closely connected to the Dutch Public Broadcasting System. Each season, the choir performs around 24 different programs, with ensemble sizes ranging from 24 to 72 singers. Most of its concerts take place within the NTR ZaterdagMatinee, the Zondagochtend Concert, and the AVROTROS Vrijdagconcert, and are generally broadcast live on NPO Klassiek. Since September 2020, Benjamin Goodson has been the choir's chief conductor.

As the pianist of the Netherlands Radio Choir you will play a crucial role in its productions. You will support the rehearsal process, accompany the choir and its singers during concerts, recordings and auditions where necessary.

We are looking for a pianist who has:

- An exceptional level of piano playing and experience accompanying choral rehearsals
- Experience working with professional choirs, ensembles, and various conductors
- Flexibility and willingness to follow different conductors and support them in realising their vision
- Excellent score-reading skills, including orchestral scores and opera repertoire
- The abiltiy to lead sectional rehearsals
- Familiarity with both contemporary and classical choral repertoire, in particular the choir's own repertoire
- Affinity with classically-trained singers
- A flexible approach within a dynamic working environment
- Strong teamwork and communication skills
- A good command of both Dutch and English
