### About Bournemouth Symphony Orchestra

One of the UK's best-loved orchestras, Bournemouth Symphony Orchestra is known for championing the role of culture in people's lives. Based at Lighthouse, Poole, the Orchestra has residencies in Bristol, Exeter, Portsmouth, Southampton, and Yeovil, and performs in towns and villages across the region. It is the largest cultural provider in the Southwest of England, serving one of the biggest and most diverse regions in the UK.

Celebrated globally for his outstanding musicianship, extraordinary interpretations, and breadth of repertoire, **Mark Wigglesworth**'s appointment as Chief Conductor builds on the BSO's reputation for the highest quality music-making. The Orchestra boasts an enviable list of named conductors, including Principal Guest Conductor **Chloé van Soeterstède**, **Marin Alsop**, **David Hill MBE**, **Kirill Karabits OBE**, and **Andrew Litton**.

Committed to new music, the BSO has presented premiere performances of works by Franghiz Ali-Zadeh, Jonathan Dove, Magnus Lindberg, Anna Korsun, Elizabeth Ogonek, Shirley J. ## Role Profile Planning and Artists Manager

**Reports to:** Head of Concerts and Artistic Planning

Location: Full-time, office-based at the Lighthouse in Poole, Dorset

#### Main Purpose of the Job:

The Planning and Artists Manager works closely with the Head of Concerts and Artistic Planning. The Manager's three key areas of responsibility are:

- administration in support of planning the orchestra's schedule
- the management of world class artists, principally conductors and soloists
- administrating the bi-annual Assistant Conductor competition

This is a key role in the BSO's Concerts team which runs the Orchestra's full-time schedule of work based in the south west of England. The Orchestra's work includes a 22-week main season of symphonic concerts, high profile engagements, a summer opera season at Grange Festival, chamber concerts, recordings and broadcasts, regional and occasional international touring.

The BSO strives to offer a warm welcome to guest artists, to create the best possible working environment and a high standard of care. The Planning and Artists Manager plays a key role in achieving this.

#### Main Responsibilities:

#### Planning

To manage bookings of rehearsal, concert and recording venues, with particular responsibility for bookings at our home venue, the Lighthouse, Poole within the terms of the Residency Agreement.

To manage the issuing of contracts for venue bookings, engagements, recordings and broadcasts.

To administrate the BSO's bi-annual Assistant Conductor competition.

#### Artists

To manage all logistical arrangements for the Chief Conductor and guest artists who frequently travel from abroad to work with the BSO. This includes being the first point of contact for guest artists, ensuring all receive a warm welcome.

To manage the issuing of contracts and incoming invoices for guest artists.

To manage immigration applications and associated administration for guest artists.

To liaise closely with artists' agents and managers on arrangements such as travel, car transfers, hotel accommodation, access requirements, practice facilities and concert tickets.

For main season concerts at the Lighthouse Poole, to be part of the concerts team running the concerts on the night with special responsibility for artists and informal post-concert hospitality for artists.

#### General

As above, to be part of the team running Wednesday evening main season concerts at Lighthouse, Poole. Otherwise, work outside normal office hours is occasional.

To work as part of the Concerts Department team, working with and supporting colleagues with the management and smooth running of the busy and complex schedule.

To liaise with other BSO departments.

To be able to respond to unforeseen circumstances which inevitably arise from time to time, for example, last minute arrangements should there be an artist cancellation.

To assist the Head of Concerts and Artistic Planning, and on occasion deputise for Head of Concerts and other members of the Concerts team.

To maintain appropriate files and records.

### **Person Specification**

Essential Knowledge, Skills and Experience

- Experience of working in the classical music profession is preferred.
- High level of organisational skills.
- Attention to detail and ability to see tasks through to completion.
- Good communication skills and ability to have empathy with guest artists.
- The ability to be calm under pressure and manage conflicting priorities.
- Computer literacy.
- Valid driving licence.
