We invite applications for the post available, to join our vibrant and thriving department in the stunning location of King Charles Court at the Old Royal Naval College, Greenwich.

The post holder will be responsible for delivering individual lessons to students aged between 5 and 19 years of age, from beginners to diploma level. The post requires working as an individual teacher but also as part of a team within our String Time programme for under 11s and our Main Programme Strings faculty, with the possibility of coaching chambers groups as and when required. Post holders will be expected to commit to 30 teaching weeks of the year, plus Staff Development morning at the start of the academic year. The position requires the post holder to be available for a full day every Saturday, although exact teaching hours are confirmed on an annual basis.

This post requires working with children and young people and is subject to an enhanced DBS check. The post holder will be required to undertake online safeguarding training as per institutional policy.

PURPOSE OF ROLE:

To be responsible to the Head of Children's and Young People's Music Programmes for the successful musical education of students between ages 5 - 18, in accordance with the requirements of the Junior Trinity curriculum. To effectively guide and support students to progress and reach their potential.

MAIN DUTIES:

TEACHING AND LEARNING

- *To develop and to disseminate examples of good practice in teaching, learning and assessment.*
- *To ensure that personal skills and knowledge are maintained in such a way as to be relevant to the students' needs and the syllabus outcomes and content.*
- *To give all students clear information about the relationships between achievement, progress and assessment and to ensure that they are aware of the requirements of the current curriculum and any examination syllabuses, where relevant.*
- *To keep detailed and up-to-date records on student progress and attendance.*
- *To contribute to procedures for regular appraisal to ensure the effectiveness of teaching, learning and assessment strategies.*
- *To prepare appropriate and effective lessons to support the delivery of any Junior Trinity curriculum.*
- *To discuss potential repertoire and programming with the Head of Children and Young People's Music Programmes throughout the year, and to provide requests for music hire in a timely fashion*

STUDENT SUPPORT AND DEVELOPMENT

- *To ensure that personal leave is taken at times which do not conflict with the efficient discharge of the above duties.*
- *To be familiar with all the Conservatoire's rules, regulations and procedures.*
- *To be familiar with current Safeguarding legislation relating to children and young people.*
- *To undertake such other related duties as the Head of Children's and Young People's Programmes (Music) may reasonably require.*

The Postholder must:

- *Be available to work on Saturdays during term time, with occasional duties during evenings or on other days in the week*
- *At all times be committed to Trinity Laban's Equality and Diversity Policy.*
- *Adhere to all policies and procedures relating to Health and Safety in the workplace.*
