# **AUDITION REGULATIONS**

#### 1. Audition organizer:

The auditions are organized by the Warsaw Chamber Opera (WOK).

#### 2. Information about auditions:

Information about the auditions will be publicly announced by WOK by posting it on the WOK notice board and the website www.operakameralna.pl under the Opera – Auditions tab at least 30 days before the planned audition date.

#### 3. Audition Date and Venue:

The auditions will take place on **22<sup>nd</sup> April 2025** at the headquarters of the Warsaw Chamber Opera (Basen Artystyczny Stage) at 6 Marii Konopnickiej Street. Candidates will be informed about the schedule, as well as the exact time and location of the auditions and rehearsals, via email at least one day in advance.

In the event of a necessary change to the submission deadline for applications with recordings or if the audition cannot be completed within the scheduled timeframe, the qualification process will be conducted on alternative dates. These dates will be publicly announced via publication at the following website: <u>https://operakameralna.pl/</u>przesluchania/.

The audition organizer is not responsible for delays and errors in electronic communication resulting from the operation of external telecommunication systems

#### 4. Nature of the Auditions:

The auditions are open. During the auditions, apart from the WOK Commission and representatives of the WOK Management, only employees of the WOK Artistic Division may be present as observers.

### 5. Applications for Auditions:

Applications for auditions should be submitted to the email address: przesluchania@operakameralna.pl no later than 15 April 2025 by 12:00 PM.

The indicated deadline is strictly binding, and applications that, for any reason, including force majeure, actions of third parties, or malfunctioning of IT services, are not received by the specified deadline will not be considered.

The application should include:

- candidate's CV,

- completed and signed Application Form Appendix No. 1 to the Regulations (downloadable from the website) with the mandatory clause concerning consent to the processing of personal data, as follows:

#### 6. Audition Programme and Requirements:

The audition programme is specified in Appendix No. 2 to the Regulations.

#### 7. Audition Procedure:

The auditions include the performance of the prepared solo programme and/or solo programme with accompaniment, as well as the designated orchestral excerpts. The complete set of sheet music with the required orchestral excerpts will be published on the audition website.

#### 8. Accompaniment:

WOK does not provide an accompanist for the auditions.

#### 9. Evaluation Committee:

The candidates' performance will be evaluated by a committee composed of no fewer than 5 members, selected from among the musicians of MACV (artistic director, coordinator, concertmasters and bassoon players of MACV) as well as representatives of the WOK Management. The jury will decide the course of the auditions. The proceedings will be recorded by a secretary.

#### **10. Evaluation Criteria:**

The committee will evaluate candidates using a scoring system from 0 to 25. The evaluation will consider the following criteria:

- Sound quality
- Technical proficiency
- Intonation
- Articulation
- Sense of style
- Overall artistic impression

#### **11. Jury Decisions:**

In case of disputes, the chairman of the jury will have the final vote.

#### 12. Preliminary Application Verification:

The organizer will conduct a preliminary verification of the applications and invite selected candidates to the auditions. By **21 April 2025**, all candidates will be informed by email about the decision regarding their qualification for the auditions.

#### **13. Audition Recording:**

The auditions will be recorded audio visually for archival purposes.

#### 14. Information on Results:

All candidates will be informed about the recruitment results by email.

#### 15. Employment:

Candidates who complete the auditions with the best results may be engaged by the WOK.

#### **16. Employment Decision:**

The decision to employ a candidate is made by the WOK Management.

#### **17. Participation Costs:**

The Warsaw Chamber Opera does not provide accommodation and does not reimburse travel expenses for the participants of the auditions.

# INFORMATION FROM THE DATA CONTROLLER FOR AUDITION PARTICIPANTS

In compliance with the requirements of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation "GDPR"), we inform you about the principles of processing your personal data and your rights related to it.

- 1. The controller of your personal data is the Warsaw Chamber Opera ("WOK"), 31 Obrońców Street, 03-933 Warsaw.
- 2. If you have any questions regarding the manner and scope of processing your personal data by WOK, as well as your rights, you can contact the Data Protection Officer at WOK via email at iod@operakameralna.pl.
- The data controller WOK processes your personal data for the purposes of the auditions as specified in the announcement: Basic identification data: First name and last name, date and place of birth, citizenship, phone number, email address, correspondence address;

Other data: photo and CV data, data from recordings.

- 4. In connection with the processing of data for the purposes mentioned in point 3, the recipients of your personal data may be:
  - a) public authorities and entities performing public tasks or acting on behalf of public authorities, to the extent and for the purposes that arise from universally applicable law;
  - b) other entities that, under appropriate agreements signed with WOK, process personal data for which WOK is the Data Controller.
- 5. Your personal data will be processed for the period necessary to achieve the purposes specified in point 3, and after that time for the period and to the extent required by universally applicable law, subject to paragraph 4.
- 6. In connection with the processing of your personal data, you have the following rights:

a) the right to access your personal data, including the right to obtain a copy of this data;b) the right to request rectification (correction) of personal data if the data is incorrect or incomplete;

- c) the right to request the deletion of personal data (the so-called right to be forgotten) if:
  - the data is no longer necessary for the purposes for which it was collected or otherwise processed,
  - you have objected to the processing of personal data,
  - the personal data is processed unlawfully,
  - the personal data must be deleted to comply with a legal obligation;
- d) the right to request the restriction of the processing of personal data if:
  - you contest the accuracy of the personal data,
  - the processing is unlawful, and you oppose the deletion of the data, requesting instead its restriction,
  - the Data Controller no longer needs the data for its purposes, but you need it to establish, defend, or pursue claims,
  - you have objected to the processing of data, pending the verification of whether the legitimate grounds of the controller override the grounds of objection;
- e) the right to data portability if the following conditions are met together:
  - the data processing is based on an agreement with the person concerned or on the consent given by this person,
    - the processing is carried out by automated means;

f) the right to object to the processing of data – to exercise this right, you should contact WOK at iod@operakameralna.pl or at the WOK's registered office address, unless we can demonstrate that the processing is necessary for purposes arising from legitimate interests pursued by the Controller or by a third party.

- 7. If the processing of personal data is based on the consent of the individual (Article 6(1)(a) GDPR), you have the right to withdraw this consent at any time. The withdrawal does not affect the lawfulness of the processing carried out based on the consent before its withdrawal
- 8. If you become aware of unlawful processing of your personal data by WOK, you have the right to lodge a complaint with the supervisory authority responsible for data protection matters.
- 9. When the processing of personal data is based on the consent of the individual, providing your personal data to the Controller is voluntary.

- 10. Providing your personal data is mandatory when the legal basis for processing personal data is a legal provision or a contract between the parties.
- 11.
